EMEA is an independent research institution and forum of debate that provides innovative, forward-looking thinking and political, socio-economic and financial integrated analyses on Europe, the Mediterranean and Africa in an emerging multipolar world. As a "think and act tank", it strives to contribute decisively to the transition process in the Mediterranean and Africa amidst climatic challenges, unprecedented global financial and economic crises and geopolitical uncertainties and conflicts.

Message from the President

2021 was marked by new uncertainties and challenges, still reeling from the eruption of COVID-19 pandemic in March 2020. Climate challenges continue to pressure countries in these regions to act in times where short term priorities are overshadowing longer term targets.

Exceptional policy measures worldwide prevented a major economic collapse, but the diverse fiscal spaces available to different governments led to inequality in policy response to the health and economic crises. Countries with ample fiscal positions were able to allocate budgetary support to social protection mechanisms to avert the breakdown of health systems, social unrest, and the worst eventualities; countries with less economic firepower were less successful. Despite compensatory measures, inequality, poverty and unemployment among young people and women increased, especially in the Mediterranean and Africa.

In this turbulent context, EMEA continued its activities researching innovative and sustainable options for the socio-economic future of the region, and implementing EU-funded projects supporting entrepreneurship, economic development and sustainable energy transition. Over the course of the year, we produced 39 publications and organized 14 events including webinars, annual conferences and seminars.

The Euro-Mediterranean Network for Economic Studies (EMNES), an economic policy research network run by EMEA, produced 15 studies, working papers and policy papers, and in December 2021 officially enlarged its scope to include Africa and become EMANES, setting the Africa-EU partnership and cooperation as a key pillar for research in 2022.

EMEA research

EMEA strives to explore and understand the socio-economic and political challenges facing economies in the Euro-Mediterranean and Africa, amidst global geopolitical uncertainties, economic and financial crises and protracted conflicts. EMEA's research aims to offer sound evidence-based analyses, policy answers and targeted actions and initiatives to address the most pressing political, economic, financial, social and environmental issues in the region.

Socio-economic Policy

In 2021, EMEA launched new research into neuroscience policy, aiming to enhance knowledge on brain health and promote the new concept of "Brain Capital" as a triggering element for reconceptualizing and revitalizing the economy. The research will examine the application of ideas from neuroscience and medicine to economic and social policy.



Money, Banking and Finance

Amidst persistent calls for debt relief to mitigate the socioeconomic consequences of COVID-19 in Africa, debt transparency continues to be an even more pressing issue. The Debt Transparency Initiative launched by EMEA in 2020 to enhance knowledge of debt-related issues, particularly in low-income countries (LICs) and lower-middle-income countries (LMICs), continued collecting data on sovereign debt for Angola and Ghana in 2021.



Regional Integration & Partnerships

The EMEA Africa Initiative brings together leading economists and high-level international and local experts to think for the future of EU-Africa policy and economic relations and partnerships. In 2021, EMEA completed its research on the EU-Africa partnership and will continue monitoring regional integration.



Publications

EMEA produced 39 publications in 2021, including studies, reports policy papers and working papers. EMEA's in-house studies disseminate economic policy research to explore and assess the socio-economic drivers of transparent, responsible, inclusive and sustainable development and growth models in the Mediterranean region.

Financial Inclusion in the Southern and Eastern Mediterranean Countries

Rym Ayadi, Mais Sha'ban, Sandra Challita et al.

This study provides an in-depth analysis of the state of financial inclusion in five countries in the South and East Mediterranean: Egypt, Jordan, Lebanon, Morocco and Tunisia. The main aim is to investigate the salient features of FI, the barriers to achieving FI, and the regulatory framework and policies used to promote FI in each country.

The Euro-Mediterranean Blue Transition Scenario 2050

Ioannis Charalampidis, Panagiotis Karkatsoulis, Leonidas Paroussos

This model-based analysis aims at providing a consistent projection of the energy and economic systems for the Euro-Mediterranean (EU-MED) countries within the Blue Transition narrative, taking into account the capacity constraints and the comparative advantages for growth of each country.

Assessing the role of Credit Guarantee Schemes in the Southern Mediterranean – Pre and During COVID-19

This study updates and extends the knowledge of credit guarantee schemes (CGS) in the South Mediterranean, while providing a preliminary assessment on the role of CGS during and post COVID-19, based on a survey and various stakeholder engagement sessions conducted in 2020.

Education and Training Policies in Response to COVID-19: Preparing for the Recovery – A focus on Arab Mediterranean Countries

Rym Ayadi, Sara Ronco

This study provides an overview of the socio-economic impact of COVID-19 in the Arab Mediterranean countries (AMCs), zooming in on education and training systems and policies, analysing their resilience in managing and resisting the crisis and how lessons learned can be embedded in recovery plans and long-term reform processes.

Projects

EMEA leads and participates in projects funded by the EU under programmes including ENI CBC Med, Interreg and NEAR, which finance cooperation projects to foster fair, equitable development on both sides of the Mediterranean, and Horizon 2020, a Research and Innovation programme taking discoveries and breakthroughs from the lab to the market.



CREACT4MED

CREative Entrepreneurs ACTing FOR the future MEDiterranean (CREACT4MED) aims to enhance the role of culture and creativity as a vector for employment and resilience in countries of the Southern Mediterranean by unleashing the potential of the cultural and creative industries (CCI) to create economic value, enhance growth, create decent jobs and foster social inclusion, with a particular focus on young people and women. The project is coordinated by EMEA.

Total budget: €2.2 million, of which 90% is funded by the EU Commission
Implementation: March 2020 – August 2024. <https://creativemediterranean.org>

2021 highlights:

- Mapping: workshops and consultations were held with stakeholders, incubators, EU Delegations, and the CREAT4MED Technical Experts Group to map the CCI ecosystem in CREAT4MED target countries, including national, regional and international stakeholders, institutions and initiatives. Final reports were published for Tunisia, Egypt and Lebanon, identifying opportunities and barriers to CCI development, and concrete policy recommendations.
- Training: applications to the CREAT4MED training academy were opened in October 2021, and trainers recruited from November 2021. The academy is due to start in 2022.
- Sub-granting: a call for proposals from incubators and Business Support Organisations was launched and winners were selected from Egypt, Tunisia, Lebanon and Jordan.
- Engagement and Advocacy: the first CREAT4MED Annual Conference was held in November 2021, bringing together CCI entrepreneurs and experts from across the region, with the aim of raising awareness of the role of culture and creativity as a vector for employment and value generation in Southern Mediterranean Countries.

The event was broadcasted live on Facebook with great success, achieving over 9,500 video views and an event reach of 31,500 people.

Projects



INVESTMED

Co-funded by the European Union under the ENI CBC Mediterranean Sea Basin Programme, INVESTMED aims to boost the sustainability and competitiveness of MSMEs, start-ups and recently established enterprises with training on sustainable business management, coaching and incubation services, and financial support.

Total budget: €3.8 million, of which 90% is funded by the EU under the ENI CBC MED Programme. Implementation: September 2020 – March 2023. <https://www.enicbcmec.eu/projects/investmed>

2021 highlights:

- Consultations with Business Support Organisations and key stakeholders in Lebanon and Tunisia were held, to map the ecosystems of the target sectors and assess skills gaps and training needs of entrepreneurs.
- The INVESTMED Sustainable Business Management training course was launched, with 5 cycles of new trainees inaugurated across Egypt, Lebanon and Tunisia. A complementary series of seminars was launched alongside this rolling programme.
- Calls for sub-grant applications were opened both to incubators and Business Support Organisations, and to entrepreneurs and MSMEs across all three countries, with partners collaborating in a series of info days to motivate applicants and resolve queries.



Interreg Med Renewable Energy Project

The Interreg Med Renewable Energy Project is one of the 8 MED Horizontal Projects of the Interreg Med Programme, co-financed by the European Regional Development Fund. The project aims to set a governance model for energy transition in rural areas and islands in the Mediterranean Region.

Total budget: €1.4 million,

2021 highlights

- A Training Programme was delivered dedicated to projects within the Renewable Energy Community: PEGASUS, PRISMI, LOCAL4GREEN, COMPOSE, FORBIOENERGY, and STORES.
- ETU Flagship Call was launched to find local entities to test the ETU toolkit and model in their energy plans, renewable energy communities or energy efficiency projects.
- 9 flagship cases were selected, along with a group of 5 cases dedicated to groups of municipalities, and mainstreaming actions and coaching were undertaken.
- Green Living Areas Learning Programme was developed, to be launched in 2022.
- The project participated in events such as Sustainable Energy Week 2021.

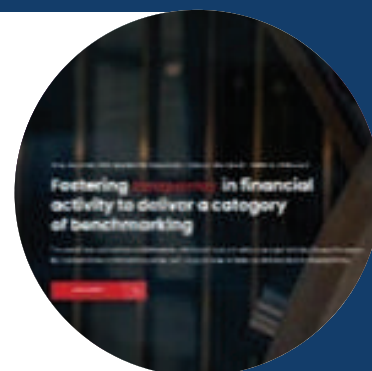

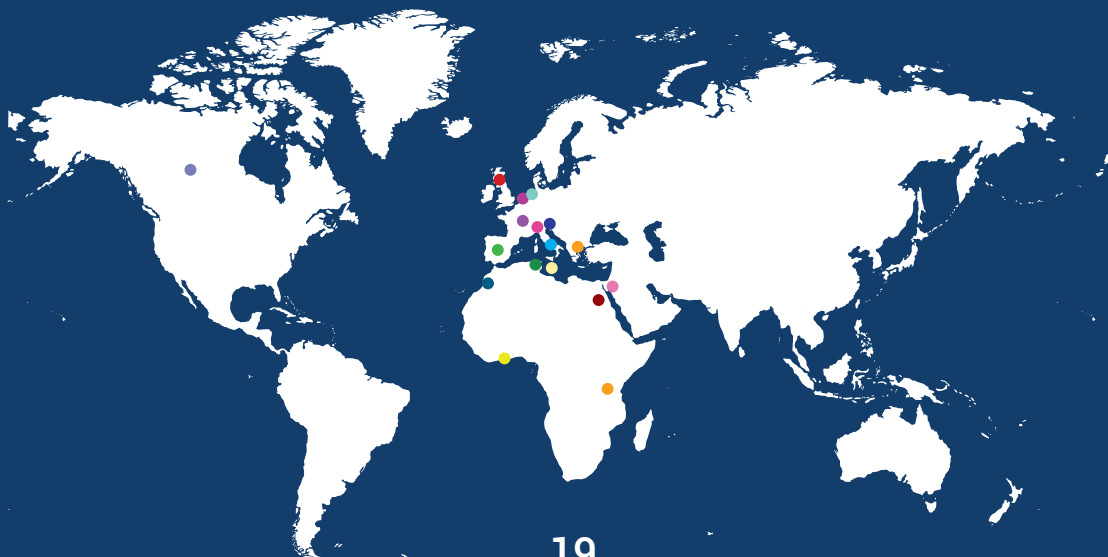
