Message from the President

2022 was the year of war in Ukraine and of the major economic disruptions produced by high prices of energy and food particularly in Europe, the Mediterranean and Africa. Countries in the latter struggled with fiscal constraints put at a test during the COVID 19 pandemic, were unable to resist the new shock waves coming energy and food crises. Between short-term and long-term challenges stemming from economic hardship, government indebtedness continued to raise getting step by step closer to disorderly default scenarios and absence of global stabilization and restructuring deal. Inequality, poverty and unemployment among youth and women persisted while little to no safety net to protect despaired populations.

Against this backdrop, the Euro-Mediterranean Economists Association has been making strides in research and advocating for resilient, sustainable, inclusive and just policies. Over the course of this year, we have held and participated in over 63 events, including 4 EMEA led events and 11 participations in numerous pavilions at COP27 in Sharm El Sheikh, Egypt in November. EMEA also released 18 publications across the EMEA and EMANES networks, as well 3 external publications such as our contributions to the G20-T20 under Indonesia Presidency.

Coupled with this agenda, EMEA launched the Sustainable Transformative Alliance for Sustainable Transformative Action, a public, private, academia collaboration with the aim of developing innovative thinking and projects to accelerate the transition towards a sustainable, greener, and resilient models in Europe, the Mediterranean and Africa.

Also this year, EMEA has co-founded and launched the Brain Capital Alliance aiming to drive policies that consider brain capital which not only offers a pathway to understanding the new economic and social reality, but can also be a driver of resilience by building brain skills and brain health over a person's lifetime. To enhance open access knowledge and informed monitoring of regional societal challenges and actions to tackle them, EMEA launched the Transparent, Responsible, Inclusive and Sustainable Dashboard and the Brain Capital Dashboard.

Bringing together these initiatives, EMEA is working to produce more resilient, transparent, responsible, inclusive and sustainable societies well equipped for the social and economic transformation.

Economy

EMEA research and Initiatives

EMEA strives to explore and understand the socio-economic and political challenges facing economies in the Euro-Mediterranean and Africa, amidst global geopolitical uncertainties, economic and financial crises and protracted conflicts. EMEA's research aims to offer sound evidence-based analyses, policy answers and targeted actions and initiatives to address the most pressing political, economic, financial, social and environmental issues in the region.

Socio-economic Policy

TRIS Dashboard

EMEA developed the innovative "TRIS" concept for socio-economic development in the Mediterranean. TRIS stands for "Transparent", "Responsible", "Inclusive" and "Sustainable". This new concept can be enlarged in other regions of the world including Africa. Research, surveys and policy analysis are intended to inform policy actors about this new concept and how to implement in economic policies. The TRIS Dashboard was launched this year.



Brain Capital

In 2022, EMEA continued its research into neuroscience policy, aiming to enhance knowledge on brain health and promote the new concept of "Brain Capital" as a triggering element for reconceptualizing and revitalizing the economy. The Neuroscience-inspired Policy Initiative considers brain skills and brain health as an indispensable part of the knowledge economy. OECD – NAEC promotes this concept as an approach for thinking about the economy and how it works in new ways and is laying some of the groundwork, looking at relevant metrics and building up a network of interested actors in the medical field, neuroscience, philanthropy and business.

Sustainable Transformative Alliance

At COP27, EMEA held the event Towards an innovative and integrated transformative action to tackle climate change and officially launched the Sustainable Transformative Alliance. The aim of the STA is to contribute to the implementation of climate adaptation actions in Europe, the Mediterranean and Africa through a transdisciplinary approach based on identification of needs and opportunities, knowledge transferring, and encouraging transformative policies. STA is addressed to high-level stakeholders, regional and local authorities mainly municipalities, and to the ecosystem of financial institutions, companies, businesses (SMEs, MSMEs), research organisations and that are interested in applying the STA framework and monitor their results for enhancing policies.



Money, Banking and Finance

To advance our initiatives in Money, Banking and Finance, we have continued to participate in events such as DebtCon5, the Fifth Sovereign Debt Research and Management Conference, Landmark Conference on Sustainable Finance in Memory of professor Clas Wihlborg and carried out a series of webinars on the topic.

Regional Integration & Partnerships

The EMEA Africa Initiative brings together leading economists and high-level international and local experts to think for the future of EU-Africa policy and economic relations and partnerships. Under this context, EMEA held webinars on the topic including EU-Africa Partnership: What Next? Towards an African Stability Mechanism. The initiative will continue developing in 2023.







Projects

EMEA leads and participates in projects funded by the EU under programmes including ENI CBC Med, Interreg and NEAR, which finance cooperation projects to foster fair, equitable development on both sides of the Mediterranean, and Horizon 2020, a Research and Innovation programme taking discoveries and breakthroughs from the lab to the market.

CREACT

CREACT4MED

CReative Entrepreneurs ACTing FOR the future MEDiterranean (CREACT4MED) aims to enhance the role of culture and creativity as a vector for employment and resilience in countries of the Southern Mediterranean by unleashing the potential of the cultural and creative industries (CCI) to create economic value, enhance growth, create decent jobs and foster social inclusion, with a particular focus on young people and women.

The project is coordinated by EMEA.

Total budget: €2.2 million, of which 90% is funded by the EU Commission

Highlights:

Mapping

Workshops and consultations were continued to be held in 2022 stakeholders, incubators, EU Delegations, and the CRE-ACT4MED Technical Experts Group to map the CCI ecosystem in CREACT4MED target countries, including national, regional and international stakeholders, institutions and initiatives. Final reports were published for Palestine, Jordan, and Morocco identifying opportunities and barriers to CCI development, and concrete policy recommendations. Following the success of the country reports, the project created a data observatory to collect and show reliable available data on Cultural and Creative Industries (CCI) under one dashboard.

Training

The CREACT4MED Training Academy was inaugurated in May with the first cycle being completed in June with 377 applications received and 84 completing the training. The second training cycle will be completed in 2023.

Sub-granting

The project closed its call for incubators and selected one organization from each target country. The project also launched a call for cultural and creative business proposals. So far, the project has selected 4 from Jordan, Morocco, Lebanon, and Tunisia. The proposals from Egypt and Palestine will begin the selection process in 2023.

Engagement and Advocacy

The second CREACT4MED Annual Conference was held in November 2022, with great success bringing together CCI entrepreneurs and experts from across the region. At the end of the conference, a networking event was held under the framework of CREACT4MED EU-Southern Neighbourhood Creative Dialogues in collaboration with Creativeforum.si and the Slovenian Ministry of Foreign Affairs.

The project also visited 2 of the targeted countries in 2022 (Morocco and Jordan) with the remaining 4 to be visited in 2023.

The CREACT4MED engagement community building platform has grown over 2022 with now over 500 members.

INVESTMED INVESTMED

Co-funded by the European Union under the ENI CBC Mediterranean Sea Basin Programme, INVESTMED aims to boost the sustainability and competitivity of MSMEs, start-ups and recently established enterprises with training on sustainable business management, coaching and incubation services, and financial support.

Total budget: €3.8 million, of which 90% is funded by the EU under the ENI CBC MED Programme.

Interreg Med Renewable Energy Project

The Interreg Med Renewable Energy Project is one of the 8 MED Horizontal Projects of the Interreg Med Programme, co-financed by the European Regional Development Fund. The project aims to set a governance model for energy transition in rural areas and islands in the Mediterranean Region.

EMANES

The Euro-Mediterranean and African Network for Economic Studies (EMANES) is a network of 35 Universities and research Institutions from Algeria, Belgium, Egypt, France, Germany, Greece, Italy, Jordan, Morocco, Senegal, Slovenia, Spain, Tunisia, Turkey, and the UK. It consists of a core team of over 100 experts in all economic fields, including the members of the steering, associate, and advisory committees, as well as the main EMA-NES researchers and fellows. EMANES aims to provide a renewed vision for socio-economic development in the Mediterranean region, mainly focusing on employment creation, social inclusion, sustainable development, and regional integration. EMGN

EMGN is a Network of Credit Guarantee Schemes, promoted by the Euro-Mediterranean Economists Association (EMEA) and the European Institute of the Mediterranean (IEMED), and with the support of Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ). It seeks to alleviate the region's structural constraints for MSMEs to access to finance by gathering guarantee schemes active in the countries of the Euro-Mediterranean Partnership. The network is active in training, advocacy and research and development. It currently comprises 8 institutions from the Euro-Mediterranean region and is associated with the Global Network of Guarantee Institutions (GNGI) and the European Association of Guarantee Institutions (AECM).

The <u>Sustainable Transformative Alliance (STA)</u> for Transformative Thinking and Action, for Europe the Mediterranean and Africa was launched this year at COP27. STA is a forward looking trans-disciplinary and multi stakeholders' initiative that seeks to accelerate sustainable economic models and actions that are transformative and aligned with a net zero scenario. The STA initially builds on four pillars: biodiversity and natural capital, territorial resilience, green entrepreneurship and skills, and financing mechanisms.

BRAIN CAPITAL ALLIANCE

Following on from the success of the OECD Neuroscience-inspired Policy Initiative, <u>Brain</u> <u>Capital Alliance</u> has been launched as an expanded, multi-national and multi-organisational programme. The programme focuses on neuroscience-inspired investment and public policy innovation as the two most powerful levers for change. It brings together radically diverse stakeholders spanning fields from brain science to policy, economics and finance. The concept of "Brain Capital" considers mental health and brain skills, including resilience, creativity and adaptability, as indispensable parts of the knowledge economy. This Brain Capital framework offers a new approach to mental health, human capital, and the economy. It delves into how the economy works and interacts bi-directionally with the human brain.


